## KNOW YOUR VOTING RIGHTS!

Attend the "Know your Rights" and election observer training on Thursday, October 16, 4-6pm, in room 328. This workshop is part of Social Justice Week and is presented by the National Lawyers Guild and the Public Interest Law Foundation, and co-sponsored by the American Constitution Society and the American Civil Liberties Union.

You will learn your rights as a voter in Washington state, and be better prepared to advocate for yourself if challenged at the polls, or denied the right to vote. In addition, this training will serve as one of the official training sessions for the nation-wide Election Protection coalition ([www.866ourvote.org/](http://www.866ourvote.org/)).

Election Protection is a national coalition that works throughout the year to break down barriers to the ballot box for traditionally disenfranchised voters. To that end, the Lawyers' Committee and its partners seek volunteer attorneys, paralegals and law students to serve as Mobile Legal Volunteers ("MLVs"). MLVs work in teams of two or more and monitor a zone of 4-10 polling places, respond to incidents reported through a national voter hotline (1-866-OUR-VOTE), and assist voters at the polling place. Sign-up information for volunteers will be available at the workshop.

Katherine M. Franke is Professor of Law and the Director of the Center for the Study of Law and Culture at Columbia Law School. Her scholarship is interdisciplinary in nature, seeking to explore the significance of legal subjectivity and consciousness in light of insights drawn from ethnographic, historical and literary studies. She teaches Feminist Legal Theory, Critical Legal Thought, Law & Culture and Gender Justice.

In addition to her work at Columbia Professor Franke teaches a course in Contemporary Legal Problems at a medium security women's prison and serves on the editorial board of GLQ: A Journal of Lesbian and Gay Studies. She recently completed a fellowship with the Law and Public Affairs Program at Princeton University, where she began a new project exploring the notion of the human that animates humanitarian projects in sites such as refugee camps in Darfur, freed men and women in civil war "contraband camps" and Palestinian refugee camps in Jordan.

Professor Franke has recently completed a book entitled *Subjects of Freedom* which maps the contours of rights-acquisition for recently emancipated Black people in the immediate post-bellum period in the U.S. Other writings have addressed issues of sexual harassment, sexuality as governance, and law and identity more generally. Her work has been featured in many prominent publications, including: Columbia Law School's Law Review and Journal of Gender and Law; Texas Journal of Women and the Law; Yale Journal of Law and Feminism; Chicago-Kent Law Review; and the Michigan Journal of Gender and Law.
