### International Graduate Students

#### Instructions and Important Information

- Complete the Financial Worksheet on page two.
  - Dependents
    - Eligible dependents include: Spouse, Children (under the age of 21 and unmarried).
    - If bringing dependents, you must submit a passport for each dependent.
  - Living Expenses
    - Cannot be waived for I-20 issuance even if you have your own living arrangements.
  - Total Resources Needed
    - Estimated costs are for one academic year (six credits per quarter for three quarters).
    - Transportation costs to and from the United States are not included in the estimated costs.
    - Plan accordingly, should your program design require more credits or terms.
- If applicable, have your sponsor complete, sign, and date the Sponsor Section.
- Collect and submit financial documents that meet or exceed the "Estimated Total Costs" you calculated.
  - Immigration policies require Seattle University to verify financial resources of all international applicants.
  - Photocopies, electronic copies, and facsimiles of signatures and bank documents are acceptable. Bank statement or bank verification date must be within twelve (12) months from your program start date.
  - Acceptable documents can include a bank statement, a bank letter with current available balance, a letter from a lending agency that certifies loan approval and amount(s).
  - Students receiving scholarships from their governments or employers must submit letters verifying such scholarship awards. Letters must include your name, the name of the government or agency, and the terms and amount of the scholarship.
  - Students should not plan on supporting their education through employment while being a student.
- Sign and date the Statement of Responsibility section. By signing, you certify that you and/or your sponsor have access to funding that meets or exceed the amount on line 11 in the Financial Worksheet.
- All portions of this Declaration of Finances form must be complete before Seattle University will issue an I-20.
